She has published a chapter in the recent collection *Consumption and the Literary Cookbook*, edited by Roxanne Harde and Janet Wesselius. Her main research interests are food in literature, food and gender, and women's writing.

Jennifer C. Nash is the Jean Fox O'Barr Professor of Gender, Sexuality, and Feminist Studies at Duke University. She earned her PhD in African American Studies at Harvard University and her JD at Harvard Law School. She is the author of three books: *The Black Body in Ecstasy: Reading Race, Reading Pornography* (awarded the Alan Bray Memorial Book Prize by the GL/Q Caucus of the Modern Language Association), *Black Feminism Reimagined* (awarded the Gloria Anzaldúa Book Prize by the National Women's Studies Association), and *Birthing Black Mothers*. She is also the editor of *Gender: Love* (Macmillan, 2016). Her research has been supported by the ACLS/Burkhardt Fellowship, Radcliffe Institute, and the Woodrow Wilson Junior Faculty Career Enhancement Fellowship. Her current book project is *How We Write Now: Living With Black Feminist Theory* (under contract, Duke University Press).

Julia Nitz is Associate Professor of Anglo-American Cultural Studies at Martin Luther University Halle-Wittenberg. She has served as Executive Director at the Center for American Studies and is co-founder of the Intercontinental Crosscurrents Network for the study of transatlantic women's networks in the long nineteenth century (crosscurrents.uni-halle.de). Her research focuses on the American Civil War, women's life writing, intertextual cultural studies, historiographic and museum narratology as well as Anglophone (Caribbean) film and adaptation studies. Her publications include *Georg III. Rezeption und Konstruktion in den britischen Medien* (1990–2006) (WVT, 2010), *Towards a Historiographic Narratology* (2011), and with Sandra H. Petrulionis and Theresa Schön, an edited volume on *Intercontinental Crosscurrents: Women's Networks across Europe and the Americas* (2016). Her most recent monograph *Belles and Poets: Intertextuality in the Civil War Diaries of White Southern Women*

(LSUP, 2020) establishes the extent to which literature offered a means of exploring ideas and convictions about class, gender, and racial hierarchies in the Civil War-era South.

Samantha Pinto (PhD, UCLA 2007) is Associate Professor of English and affiliated faculty of Women's and Gender Studies, African and African Diaspora Studies, The Warfield Center for African American Studies, and LGBTQ Studies. She teaches courses on African American, African Diaspora, African, postcolonial, and feminist studies. Her book, *Difficult Diasporas: The Transnational Feminist Aesthetic of the Black Atlantic* (NYU Press, 2013), was the winner of the 2013 William Sanders Scarborough Prize for African American Literature and Culture from the MLA. Her work has been published in journals including *Meridians, Signs, Palimpsest, Safundi, Small Axe*, and *Atlantic Studies*, and she has received fellowships from the NEH and the Harry Ransom Center. Her second book, *Infamous Bodies* (Duke UP, 2020), explores the relationship between 18th and 19th-century black women celebrities and discourses of race, gender, and human rights. She is currently at work on a third book, *Under the Skin*, on race, embodiment, and science in African Diaspora culture.

Johanna Pitetti-Heil (she/her) is senior lecturer for Gender and Diversity Studies at the English Department of the University of Cologne, Germany. She is a member of the EAAS Women's Network Steering Committee, co-editor of *WiN, Gender Forum* (with Judith Rauscher; http://genderforum.org/), and of the academic blog *Food, Fatness, Fitness: Critical Perspectives* (with Evangelia Kindinger and Nina Mackert; http://foodfatnessfitness.com/). She has published in the fields of American literature, cultural theory, and dance studies, including her monograph *Walking the Möbius Strip: An Inquiry into Knowing in Richard Powers's Fiction* (Winter 2016), the co-edited collection *Communicating Disease: Cultural Representations of American Medicine* (with Carmen Birkle), and articles in *Dance Chronicle* and *Hypatia*. Her current book project, "Becoming-Body: Technologies of the Self in American Modern Dance," explores the implications of corporeal materiality for the construction of subjectivity and freedom in American modern dance techniques.
